Buyback Contract - Start Here

Please review and accept the terms and conditions of our offer listed below. For your convenience, once we have received your acceptance, we will email you a prepaid shipping label for you to return your unit.

- I understand that if all the accessories listed are not included or malfunctioning, the offer will AUTOMATICALLY be amended by \$25 per missing or broken accessory.
- I understand all batteries I send will be tested for minimum battery life. If the battery does not meet the minimum battery life of 70% it will be disposed of, I will not receive payment for the battery, and the offer will AUTOMATICALLY be amended by \$25 per battery.
- I understand that if I request a stop payment and re-issuance on a check for any reason, \$25 per stop payment request will be deducted from my final offer.
- I understand I am NOT to send in any tubing or cannulas. Manuals are optional. [If you want to send your manual with your unit, it will save a few trees.]

What is a FULLY FUNCTIONING unit?

Your unit will be inspected for alarms, oxygen purity, excessive noise, smoke odor/damage, and physical damage or breakage. If the unit is not FULLY FUNCTIONAL to AMSR (American Medical Sales and Rentals) standards, the buyback amount will be decreased by the required repair amount up to the full buyback

estimate. If your unit is not fully functional, the offer will be amended as set forth below.

| \$150 or less | The offer will be amended automatically, and you will be notified of the required repairs. | - |

Note: AMSR is not responsible for lost or damaged items during shipping due to poor packaging. Additionally, AMSR values smoker units at zero dollars.
